


Pay My Loan Action Steps



1. Make sure you are registered for [Online Banking](#).
2. [Log in](#) and look for “Pay My Loan” under the Additional Services tab in the Online Banking menu, OR under Move Money in the Mobile App.



3. Select whether you would like to pay with an external account from another financial institution OR by using a debit card (Note: debit card payments are subject to a convenience fee.)
4. For external account payments, enter your financial institution name or routing number, and your account number in the Loan Pay Application. If your institution does not populate when searching by name, simply enter the routing number.

5. Save your external account information. Once added, two micro deposit transactions (less than \$.50 each) will be generated and deposited to your external account within one business day. Check your external account(s) activity for the micro deposits transaction amounts.
